Recertification---FINAL--- EFFECTIVE 03/15/2016 (Voted and Revised 11/14/2018)

Basic CERT Recertification

Team CERT status involves ongoing participation by attendance at Team meetings and trainings, County-wide trainings, individual study and other activities deemed appropriate by responsible Team Leader.

Recertification (necessary every 5 years) involves:

- New DSW form
- Photograph (blue background, if possible)
- A minimum of 25 hours of continuing education (documented) with the suggestion of completing at least 5 hours per year.
- o The Team Leader is responsible for tracking member's 5-year expiration date.
- o CERT members will maintain documentation of their continuing education.
- When less than 5 years left until DSW badge expiration the minimum hours required will be based on years left until badge expires times 5 hours, i.e., 2 years =10 hours, 3 years = 15 hours. See further information in "How to recertify".

Team meetings and training (Based on Team Leader's assessment)

Formidable Footprints

Simulated Exercises put on by Teams (up to 4 hours credit)

Modules in Basic CERT course offered in County with hours sign off by instructor.

CERT Auxiliary Advanced Training classes and exercises

Regional Training and Exercise Program (Urban Area Security Initiative (UASI)

Students need to verify with completion certificate offered by appropriate agency.

<u>Uncertified status</u>: Individuals are expected to complete the appropriate recertification activities over 5 years. CERT members will be moved to inactive status for failing to do so. They will be ineligible for call-up as a CERT volunteer and treated as a spontaneous volunteer in an emergency situation. In order to reengage as a CERT volunteer they must demonstrate mastery of Basic CERT knowledge and skills.

Basic CERT Training class completion: While completing all modules during the regular course of instruction is preferable, individuals will have one year from the end of the course to complete missed modules. All modules in the Basic CERT course taught throughout the County may be used as make-up. Students must get hours signed off by current instructor, and provide copy to the original course instructor.
