Only effective for palliative care (in a hospital environment). Because danger with of heart complications, an ECG should be taken before prescribing the drug. When talking with others, refer to CDC website. Also deprives others of Malaria treatment.

In recent days, many local jurisdictions have proclaimed local states of emergency and/or public health emergencies and on March 4, Governor Gavin Newsom proclaimed a State of Emergency for California. On March 12, the Governor issued Executive Order N-25-20, which, among other measures, directs citizens and agencies to observe the social distancing guidance issued by the California Department of Health on March 11, specifically as to gatherings and meetings. The intent of these measures is to slow the spread of the virus by limiting people's exposure to infected individuals.</p> <p>To our Clients: We will be happy to reschedule your program at a later date. <p>Coronavirus: COVID-19: Coronaviruses aren't new to us. There are different types that can present with respiratory or gastrointestinal symptoms. The 2019 Novel Coronavirus was first discovered in a group of pneumonia patients who also had contact with a seafood and live animal market. Sometimes these diseases can spread from animals to humans in what the medical community calls a "spillover." We don't yet know the origin of the 2019 Novel Coronavirus, or exactly how it's transmitted, but we're quickly gathering information on transmission and symptoms, which we'll provide in this program. We'll also discuss ways to prevent infection.</p> <p>For the latest guidance, Centers for Disease Control (CDC) and Prevention, state or local health department websites are recommended. CDC: https://www.cdc.gov/coronavirus/2019-ncov/index.html CDPH: https://www.cdph.ca.gov/Programs/CID/DCDC/Pages/Immunization/ncov2019.aspx</p> <p>Coronavirus Precautions and Prevention: Common Sense Hygiene: You've heard of COVID-19, or the coronavirus, and its rapid spread around the globe. Perhaps one of the first things that came to mind was, "How do I prevent myself and my family from getting the virus?" This program compiles expert advice on how to prevent the spread of coronavirus and keep yourself and loved ones healthy.</p> <p>Coronavirus Precautions and Prevention: Coronavirus Preparedness: The emergence and spread of COVID-19, or the coronavirus, is a worldwide concern. If you're not under quarantine, there's a chance you could be at some point. So, it's important to start collecting items for a coronavirus preparedness kit. This is just like any other emergency kit you might have, like one for a major earthquake in your area or getting stuck in a blizzard in your car. It's a way to be prepared ahead of time, before there's a run on supplies.</p> <p>Coronavirus Precautions and Prevention: Stay Calm, Stay Informed: There's a lot of information out there that might make you anxious about a coronavirus pandemic. But while it's important to be prepared and prevent the virus's spread as much as possible, it's also important to keep some perspective. There have been far deadlier viruses that have spread more widely throughout human history, and with the benefit of modern science and medicine, we will do much better than in the past. In this course, we'll talk through what exactly we know about the virus and any treatment options currently being developed.</p> <p>Coronavirus Precautions and Prevention: Travel Safely: The coronavirus, COVID-19, spreads more easily the more people are grouped together, so you can imagine how busy airports, city buses, and subways pose the greatest risk of infection. The virus is capable of spreading very quickly, and has reached several thousand confirmed cases, most notably in places like Italy, Iran, South Korea, and China. The effects vary from person to person, but of course, you should take every precaution to avoid infection. With all that in mind, let's talk about travel. MGT-335-W Event Security Planning for Public Safety Professionals: This self-paced, Web-based course is designed to provide planning and management-level skills to officers from state and local law enforcement agencies. Participants will be provided with the essential skills and knowledge to understand the importance of and the need for planning and managing security for special events, and to identify guiding principles for special-events security.	
AWR-209-W Dealing with the Media: A Short Course for Rural First Responders: Adapted from FEMA's IG-290 curriculum, this 6-hour course provides rural first responders with skills needed to communicate with the public through the media. Examines roles of the media and the rural first responder/public information officer. Participants learn how to give print/electronic media interviews, write news releases, provide information at the scene, and how they fit into the joint information system.	
AWR-148-W Crisis Management for School-Based Incidents: Partnering Rural Law Enforcement, First Responders, and Local School Systems: This self-paced, Web-based course will educate rural law enforcement personnel as well as school administrators, teachers and staff to effectively respond to an emergency in a K-12 environment. The training will provide representatives of rural law enforcement departments and school systems with a foundation of knowledge and skills that will enable them to progressively establish a school-based emergency response plan and crisis management team through information-sharing and training.
