OES transitioning to Office of Response, Recovery and Resilience (OR³)

The OR³ office will be in the County building on Water St. Unknown status for the Emergency Operations Center (EOC). The CERT interface is undetermined. Most likely will be a part of the Resilience section with other Community Partners.

--CERT Council

Felton Fire Chief Bob Gray is the president of the CERT Council the conduit from the county to CERT via the Emergency Management Council (EMC).

CERT Council formed from EMC in 1989 when the state started giving money for CERT. This stopped in 2011 when the funding dried up. It reactivated after formation of the CERT Auxiliary in 2015. CERT Council Meetings on first Monday of month -- next April 5th 9-11am.

Temporary Evacuation Point

--Only a single point now -- Scotts Valley Community Center is only TEP operating. All traffic certified CERTs are on alert for possible activation. Activation order will be sent when the evacuation order is made (previously it was 24 after the evacuation order). Plan 3 CERTs working each of 3-hour shifts (7-11am, 11-3pm, 3-7pm) the first day then 4 CERTs each shift thereafter. Virtual TEP created by Red Cross for resource help. Call-in center also will be available.
